Candidate decided to use personal funds to make up the negative balance and wrote a check in the amount of \$108.51. Instead of having the candidate deposit the personal check into the committee's account (which is closed) and then having her write out a committee's check to escheat the \$108.51 to the State of Iowa, I advised candidate to write the personal check directly to the State of Iowa and mailed to our office to process the escheat check. I, the auditor, am making this entry with the candidate's permission in order for the candidate to dissolve the committee. VVS
